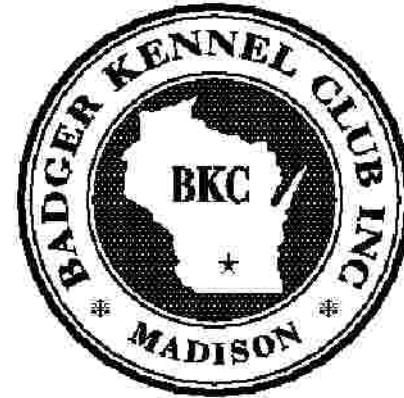


# Two AKC Sanctioned B Matches

## AGREEMENT

I (we) agree that the Club holding this Match has the right to refuse this entry for cause which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Match and of the opportunity to have the dog judged and to win ribbons or trophies, I (we) agree to this club, its members, directors, officers or Match Secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or any thing by the act of this dog while in or upon the premises or grounds or near any entrance thereof, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, or injury, be caused or alleged to be caused by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for an agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this Match, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or of their employees or any other persons.
