DIRECTIONS TO THE SHOW SITE

From North (Fond du Lac/Green Bay): Take Hwy 151 to I90/94 north of Madison. Go west on I90/94 to Hwy 51 South, exit #132.

From West (Wisconsin Dells): Take I-90/94 toward Madison. Exit at Hwy 51 South, exit #132.

From South (Janesville), take I-90 north toward Madison. Exit at Hwy 51 South, exit #132.

From East (Milwaukee): Take I-94 to I-39/ I-90 West toward Wisconsin Dells. Exit at Hwy 51 South, exit #132.

From Hwy 51 South Exit: Go south on Hwy 51 to first stoplight (CTH CV/Anderson Road) and turn left. *Look for the colorful water tower.* Turn left on Haase Rd. then take the fifth (5th) driveway on the right-hand side on Haase Rd. The BKC Training Center is located on the north side of the parking lot. **Be sure you are on Anderson Road, not Anderson Street.**
